- At-large councilman (since 2012) and chair of education committee
- Few priorities in Education
 - o Discipline standards
 - Banning suspensions of pre-K students—over 180 Pre-K Students expelled or suspended
 - Getting more mental health services into the schools
 - o Literacy skills gap—trying to improve the early gap
 - o Working with many agencies, including DCPS, OSSE, Public Charter Board, DC Public Libraries, Adult workforce education
 - o Homelessness—it impacts schools
 - Linking work to Health and Human Services
 - More than 2,000 homeless kids
- 10 staffers—all been with him or in DC government for a while

Questions from ECA members

- o How do we engage with the homeless population in our local area?
 - There are service providers in the area
 - Trying to reduce chronically homeless people—adopted a housing first policy
 - It is still an ongoing problem, but the city must realize that what we've been doing hasn't been working

o With the national reduction in funds for public education, how do we deal with getting the needed funding?

- We spend \$1.8 billion on education in the District; how can we move it around to make sure it's having the right impact?
- How can other agencies help students and schools? How can the other agencies engage?
- We need to find more money; but also account for the money being spent.
- New Deputy Mayor, Jennifer Niles, is trying to make connections between charters and DCPS. The charter system should help the whole system become better.

o Is there work in encouraging college attendance?

- UDC and CC are part of the purview of the committee
- UDC is going through re-accreditation
- Honestly, UDC has a lot to go

 CC started up just a few years ago—there is a tremendous amount of need

o What are your top 3 priorities—since there is so much going on?

- 1) student discipline
- 2) literacy work, including funding effective programs through the budget
- 3) homelessness, criminal justice, etc.

o Teacher retention and discipline—is there a connection>?

- We are looking closely at retention for teachers and principals
- Not sure if there's a direct connection
- Teachers asked for the ability for in-school suspensions
- Principal at Anacostia went from over 100 arrests in the school down to 3

Presentation from RAP, looking for support for a building project

- 1959 4th Street NE
- Project manager and architect
 - o Current project—new building being constructed
 - o They have come to ANC and have always gotten support
 - o The current building will be over 9,000 square feet
 - o Four levels with parking
 - o <u>We are here tonight seeking a letter of support for a green roof</u>—need a zoning variance for that
 - We can put a green roof up there, but need a stairway to get up there
 - There is currently a stair, but only to 3rd level
 - They have a building permit
 - o Want to be able to grow vegetables; we have a hatch right now, but want a stairway
 - o 9 feet above the roof line
 - o Question from ECA members
 - When this plan was presented 3 years ago, you presented that you would not go above the current height
 - We have a building permit; we can go to three stories—and 40 feet. We are currently in compliance. Now we want a variance to go beyond the 40 feet.
 - Have you gotten support from neighbors?
 - We have support from yellow house and others
 - This meeting and also the ANC
 - Letters were sent out to neighbors—do you have letters?
 - o "Yes" but not produced.
 - Registered letters always come back
 - At the beginning of the process we wanted to see if there was a basement next door. We tried to get in touch with the owner, but we couldn't get in touch
 - Sylvia—there has to be a registered letter to neighbors 200 feet from the property
 - Is there an alternative solution?

- A hatch
- Should we do a letter of support or opposition?
 - Comments from community members:
 - o They should have come to us much sooner in the process.
 - o They should have had more information about the support of neighbors.
 - o This developer initially told us that their additions would look similar to the construction
 - o The building is not aesthetically pleasing
 - Initial drawings a few years ago were nothing like this. They wanted to focus on the Victorian nature of the building and this is very different.
 - There was not a resolution to support
