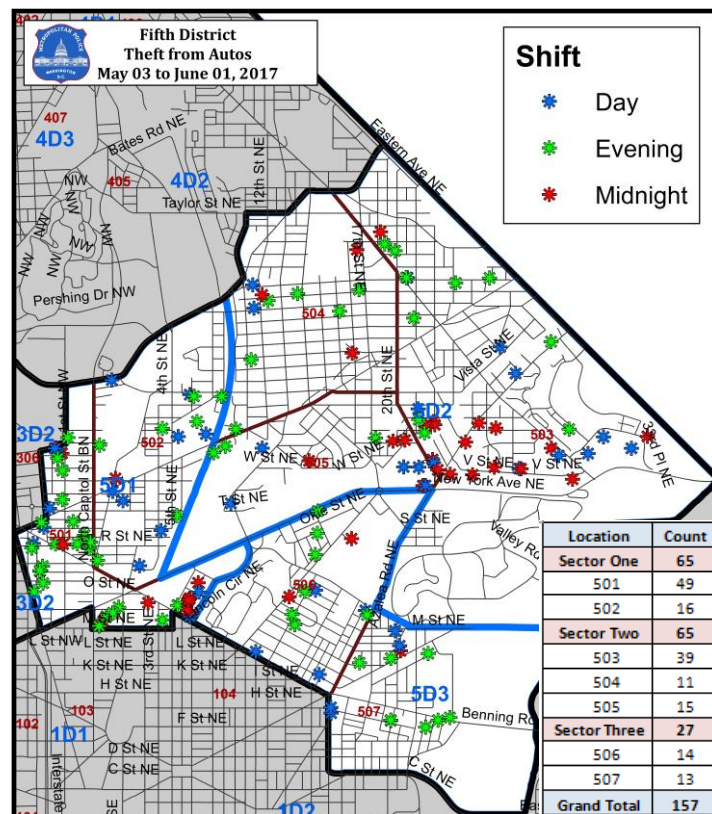

Executive Summary: The following report is a 30-day overview of Theft from Auto cases in the Fifth District. In the past 30-days, one-hundred and fifty-seven (157) TFAs occurred in the Fifth District. When compared to the previous 30-day time frame, TFAs increased 51%, up fifty-three (53) cases. Sector One had the greatest increase during this time frame, up 124% or thirty-six (36) cases. With respect to the same 30-day time frame in 2016, TFAs increased 18%, up twenty-four (24) cases.

Overview:

- Sector One and Sector Two each had sixty-five (65) TFAs.
 - 75% of cases in Sector One occurred in PSA 501
- The evening shift was most active with sixty-seven (67) cases.
- 45% of cases occurred between 1600-2359 hours; thirty-five (35) cases between 1600-1959 hours and thirty-six (36) cases between 2000-2359 hours.
- Cases were most common on Saturdays with forty (40) cases
- Significant upticks in cases were reported between 2000-0359 hours from Saturday night into Sunday morning.
- The 1200 block of 5th St NE (PSA 501) had the highest number of repeat cases during the examined time frame.
 - 1274 5th St NE- Three (3)
 - 1270 5th St NE- One (1)
 - 1258 5th St NE- One (1)
 - 1266 5th St NE- One (1)



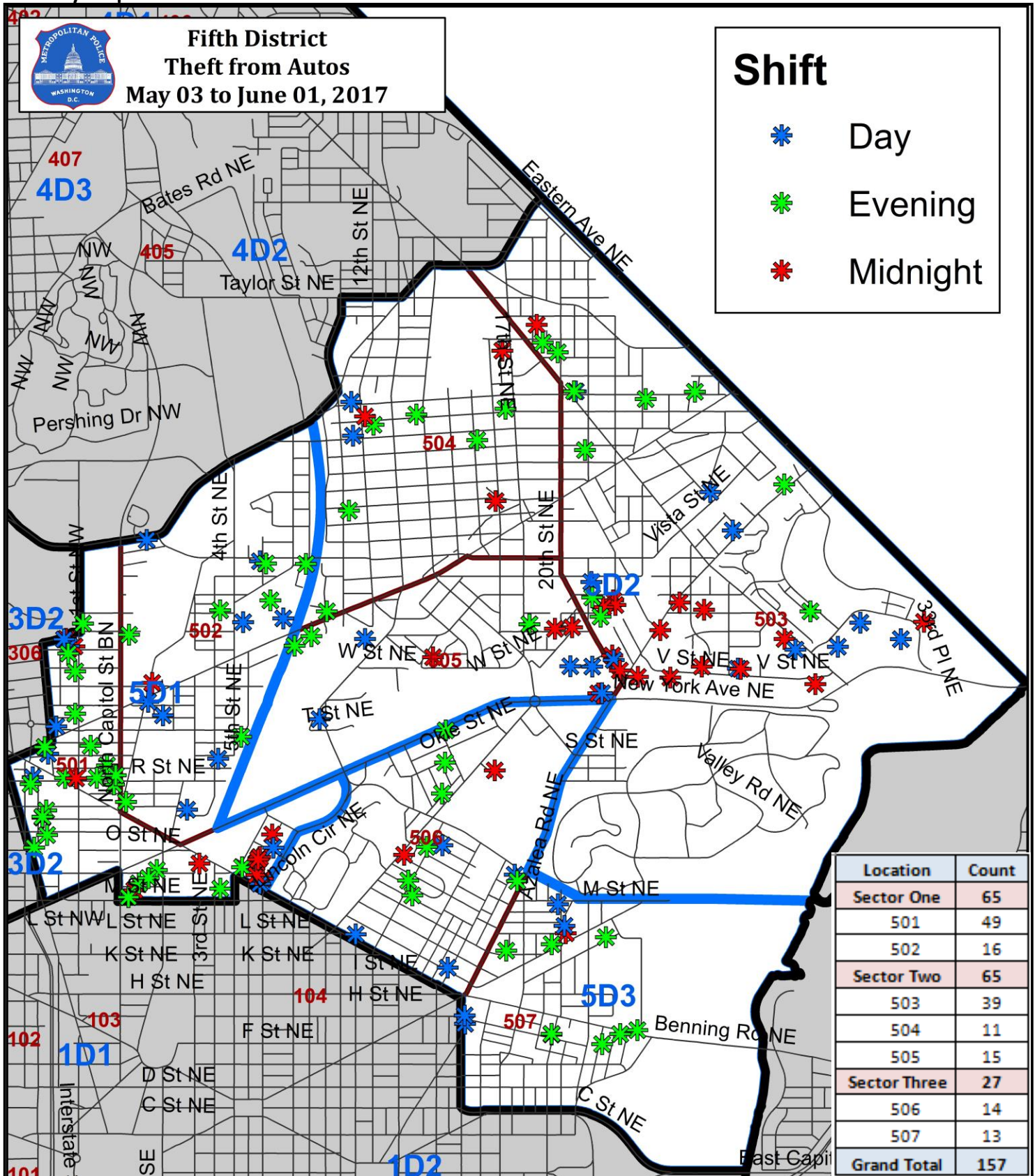
