- Eckington Day (Dana Samuels, Ben Colbert)
  - Save the Date: Saturday October 2, 2021 at Tanner Park
  - o What we're working on: fun activities for all ages in the park, music, and more!
  - Discussion of and <u>vote on</u> allocating up to \$2,500 of ECA funds to cover Eckington Day costs (some of which may be recouped from donations, fees for exhibitors)
- Discussion of and <u>vote on</u> proposed ECA Comments re: DDOT's 65% plan for Dave Thomas Circle
  - o Please review and comment on our draft comments in advance of the meeting
- Discussion of and <u>vote on</u> <u>proposed joint Eckington and Bloomingdale Civic Association letter</u> regarding study of North Capitol Street.
  - Many thanks to Eckington Parks & Arts's Mark Galvan for his efforts to coordinate the ECA, BCA, and the Deckover Steering Committee.
  - The Mayor's budget includes \$1 million for a study of North Capitol Street, including the feasibility of the deckover and other options for improving the corridor from Michigan Ave. to Mass Ave.
  - o Note: we're working with the Deckover team on a special joint meeting (details & timing TBD)

#### Quick updates:

- o With your help, we succeeded in restoring one of two amendments to the comprehensive plan
- In 2020, <u>we requested funds</u> to improve Harry Thomas Recreation Center. In this year's proposed budget, Mayor Bowser allocated \$19 million in DC's <u>Capital Improvements Plan</u> in fiscal years 2024 and 2025 to modernize the facility.
- This year, with the help of several partners, including Langley Elementary PTO, Eckington Parks, Ward 5 for All, and ANC 5E, we <u>advocated for funds</u> for a DC public library to serve Eckington, Edgewood, and Stronghold. In this year's proposed budget, Mayor Bowser allocated \$24 million for a neighborhood library to serve our communities (again, the money is allocated in FYs 2024-25).
- The budget also contains significant investments in violence interruption programs, the <u>subject of a</u>
  <u>letter the ECA transmitted this Spring to Mayor Bowser</u>. It is not yet clear where the city will choose to expand violence interruption programs.
- We are planning to move ECA officer elections to November, a month in which our meetings have typically had higher attendance than December. We'll use the last meeting of the year in December for a look back at the year's achievements, set some goals for 2022, and have a party.
- We anticipate returning to in-person meetings in September (but will hope to have a virtual participation option).
- Eckington's nonprofit community bike shop, GearinUp, is looking for a new home. We are trying to assist. <u>Please consider donating to help them with their move</u>.
