

February 14, 2022 Virtual Meeting Highlights

Decisions Taken

ECA members voted as follows:

- YES to set aside \$3,000 in ECA funds for 2022 grants to fund projects/programs/services that improve environment/health; promote community engagement; support Eckington youth; or enhance traffic/biking/pedestrian safety.
- YES on a proposed ECA letter to DMPED advocating for:
 - That all of the new housing be affordable (max 50% AMI) and that a significant portion of the units by deeply affordable (30% AMI)
 - That the new housing include a significant number of family sized units
 - That the project include a DCPL branch library to serve Edgewood and Eckington
 - That DMPED consider moving the fire station permanently to another location in the neighborhood so that the Library can occupy the ground floor (which is DCPL's preference for new facilities)
- YES on ECA letter to Mayor Bowser, Councilmember McDuffie, and Councilmember Trayon White requesting that the funding for the Edgewood/Eckington library be moved forward from FY 2024 to FY2023 so that it aligns with this development process.
- YES on a letter to DDOT re: traffic safety on 2nd, 3rd, T and 4th Streets NE.

 Councilmember to try to move forward Eckington/Edgewood library funding from FY 2024 to FY 2023,
 to fund a Ward 5 Circulator bus, to fund improvements to trail access along the MBT, and to fund
 better monitoring of industrial and other air pollution in Eckington, Brentwood, and similarly
 impacted neighborhoods.

ECA Updates

- Geoffrey Taylor, CCIM, has free COVID test kits for distribution to community members sought input on where distribution might be most effective. ECA members suggested the ECA community room, in addition to local markets and stores. Geoffrey will provide further information in coming weeks.
- The ECA voted to establish a grant process to award up to \$3,000 in increments of \$200 \$500, or \$501 \$1000 toward projects/programs/services that improve: environment/health; community

- engagement; youth; traffic/biking/pedestrian safety. The request for initial concepts is available here; concepts are due March 14, and the ECA will complete evaluation by approximately March 25. Finalists will be invited to share a short presentation with ECA members at the ECA April 14 meeting, at which the Association will vote on grants to be awarded.
- The ECA heard a presentation from EastBanc group outlining its response to the Engine 12 RFP (2225 5th Street NE and 513 Rhode Island Avenue NE). The ECA discussed that while EastBanc had to respond to the criteria in the RFP (which would retain the firehouse), members are supportive of requesting that the firehouse be moved, so that the eventual development could include a DCPL branch library to serve Edgewood and Eckington. The ECA voted to support letters to DMPED, Mayor Bowser, Councilmember McDuffie, and Councilmember Trayon White advocating for these and other points noted above.
- Short updates:
 - <u>ECA sent a letter to the Ward 5 redistricting committee</u> and testified at its recent meeting on February 8, 2022.
 - ECA budget letter re: environmental issues forthcoming

Other Updates

• The ECA heard an introduction from Christopher Wade, Community Outreach Specialist with the US Attorney's Office for DC, who is temporarily assigned to 5D (Ward 5). This role fosters the relationship between the criminal justice system and local community and can offer various forms of support (e.g., presentations to help people avoid being victims of crime and to support victims through criminal justice processes, presentations on specific issues like ghost guns, information on the status of offenders who have committed crimes in Eckington, etc.) Mr. Wade also actively participates in the Violent Crime Working Group which coordinates with DEA, FBI, Metro Transit, non-profit orgs, behavioral health orgs, and others.
